



APPLICATION PROCEDURE FOR SPORT VISA TYPE C (SCHENGEN)

APPLICANT'S DOCUMENTATION

The following documents (both in original and copy) have to be submitted by the applicant

- 1) An application form, filled-in, duly dated and signed (the application form is available at the gate of the Embassy).
- 2) One recent passport-size colour photo (must have been taken less than six months before the application), size 35mm x 40mm, full-face with white background (ICAO standard https://www.icao.int/sites/default/files/FAL/Annex_A-Photograph_Guidelines.pdf).
- 3) A valid passport or travel document, issued not more than 10 years ago, with a validity of at least three months after the end of the intended stay (hence the relative visa) within the Schengen area with at least 2 blank pages.
- 4) Evidence of previous stays in the Schengen- area (old visas) (original and one copy) if applicable.
- 5) **Medical insurance** for the applicant, with minimum coverage of EURO 30.000 (thirty thousand), for medical care, emergency services and repatriation expenses, valid for all Schengen countries.
- 6) Hotel reservation for the entire length of the visit.
- 7) Flight booking.
- 8) Valid contract with a team/club (original and one copy).
- 9) An invitation from the organizers of the sport event, stating both the financial conditions of invitation (with clear information on who is covering the costs) and the authorization of CONI (Italian Olympic Committee). The invitation will have to be sent from Italy also to the Visa Office (asmara.visa@esteri.it) prior to the applicant's appointment.
- 10) Supporting letter from the relevant Eritrean sport federation and/or association.
- 11) Digital finger prints of all ten fingers will be taken at the time of the application.

APPLICANT'S DOCUMENTATION

The following documents (both in original and copy) have to be provided by the applicant

- 1) A National Visa application form, duly filled-in and signed. According to the National Visa Code, "as a rule, the application ought to be lodged at least 15 days prior to intended date of travel".
- 2) One recent passport-size colour photo (must have been taken less than six months before the application), size 35mm x 40mm, full-face with white background (ICAO standard https://www.icao.int/sites/default/files/FAL/Annex_A-Photograph_Guidelines.pdf).
- 3) A valid passport or travel document, issued not more than 10 years ago, with a validity of at least three months after the end of the intended stay (hence the relative visa) within the Schengen area with at least 2 blank pages.
- 4) Evidence of previous stays in the Schengen- area (old visas) (original and one copy) if applicable.
- 5) Hotel reservation for the first period of the visit.
- 6) Flight booking.
- 7) Declaration of personal consent issued by the CONI (dichiarazione nominativa d'assenso) to the relevant Italian Embassy/Consulate, specifying the personal details of the athlete, their sporting discipline, and the details of the receiving club. This declaration must be accompanied by the "nulla osta" (authorization) from the relevant "Questura" to be submitted within 90 days from date of issue. (original and one copy).
- 8) Valid contract with a team/club (original and one copy).
- 9) An invitation from the organizers of the sport event, stating both the financial conditions of invitation (with clear information on who is covering the costs) and the authorization of CONI (Italian Olympic Committee). The invitation will have to be sent from Italy also to the Visa Office (asmara.visa@esteri.it) prior to the applicant's appointment.
- 10) Supporting letter from the relevant Eritrean sport federation and/or association.
- 11) Digital finger prints of all ten fingers will be taken at the time of the application.
